- IV. SSC Updates
 - A. California Distinguished School

- VI. Principal Updates
 - A. Measure J
 1. Holly brought Information for voter flyers on Measure J for any parents interested.

 - B. Wheels use on campus
 1. The messaging at the front of the school about this topic is different than on the back of the school creating confusion with some parents who reached out to the office about it. To clarify the issue, Mrs. Scroggins reached out to the District and confirmed that bikes, scooters and wheels are NOT ALLOWED in campus at all, not even on weekends.
 2. The school area with the buildings is off limits when school is not in sessions, only the black top area (grass, play structure and basketball courts) are available for public use off school hours.
 - C. School capacity
 1. Amador is pretty full. New families moving in throughout the year might not be able to join and will need to be diverted to another school. If parents raise the concern that they have the right to be served by their neighborhood school we can assure them that the obligation is for the Dublin School District to find a school placement for their kids and that in the event there are not spots available at Amador (their assigned school), the district will place you in the closest school to you that has spot available.
